-10E to San Bernardino  
\* Take Waterman Ave. North Exit 73B  
\* Keep Right to Waterman Avenue  
\* North ramp >>Turn Right on Waterman Avenue  
Continue on Waterman Avenue - Approx 5 miles  
(pass Baseline Avenue ....keep on Waterman Ave)  
\* Turn Right onto Gilbert Street heading EAST  
Drive through residential/business area 0.7 miles) to Anton Ct. with caution along Anton Elementary School toward the back to the Juvenile Court/Juvenile Detention Ctr Parking lot.

I-15 - via 210 E to 115A >>Exit CA -18 Waterman Ave

- \* Exit on to Waterman Ave
- \* Keep Right to Exit on Waterman Avenue S
- \* Turn Right on to Waterman Avenue

Continue on Waterman Avenue - Approx 4 miles  
(pass Highland Avenue ....keep on Waterman Ave)

- \* Turn Left onto Gilbert Street heading EAST (Drive through residential /county buildings area 0.7 miles) to Anton Ct.

Turn Left onto Anton Street/ on your right is Anton Elementary School . Drive with Caution along elementary school

- Stop Sign (Corner of Anton & Paseo Drive) - Turn right  
Onto quick left onto street Into parking lot of Juvenile Court/Juvenile Detention Center
